## BISHOP & ROOK UK LIMITED (IN CREDITORS VOLUNTARY LIQUIDATION) ("the Company")

Further to my letter sent to all known US customers of 28 June 2024, I now provide an update to you as the director of the Company on the actions taken by me as Liquidator, what has been reviewed and my conclusion for each project following advice taken from my solicitors on the position.

## Actions by the Liquidator taken since the letter of 28 June 2024
